Good evening Bruce.

My 2nd Assistant Chief and myself had recently put together data to support the purchase of a universal use UTV - used for both grass fires and rescue/ems operations in remote locations. This was one of our 3-5 yr outlook ideas, planning to keep Fredonia Fire Department as a strength in the north end of the county.

Here is our data that we put together to support that purchase.

Rural Area

72 sq miles of mostly rural community on north end of Ozaukee County

Snowmobile Trails

Over 62 miles of trails on the north end of Ozaukee County. 12 miles of that are in our rural coverage area.

Public Recreation Areas - 933 total acres

Old Girl Scout Camp (South of Fredonia/Hawthorne Road) - 116 acres

Waubedonia Park - 103 acres

Harrington Beach State Park - 715 Acres

Wildlife Habitat - Wildland area

2,080 acres of grassland (north end of county)

Fredonia is on 14 Mutual Aid Cards (Spanning 3 Counties) for grass fires

Long Driveway (Direct Response Area)

(9) Driveways over 1000' in length and limited access

We had priced out a Polaris Ranger Crew XP 1000 UTV. Quote is attached  
This unit was direct from Polaris, outfitted with an emergency light package, 6000# Winch, a fire and rescue skid w/6 hp Pump, and windshield / roof package.  
Price for this unit in May 2022 was listed at \$45,405.30

This would definitely be something that could be utilized by both the Fire and Police Departments, and would be an excellent idea to utilize ARPA funds for. As ATV and UTV recreation becomes more popular in our area we are at higher risk for more potential remote UTV/ATV Accidents.

I would target our Fire and EMS Association to purchase and donate a trailer

package for this unit. Also would look at tracks for this unit - another potential Fire and EMS Association.
